
ADMINISTRATIVE ORDER

FEDERAL RULES OF CRIMINAL PROCEDURE -- RULE 58(d)(1)

Forfeiture of collateral in lieu of appearance will be in accordance with the following procedures:

LCrR 58.1 - Forfeiture of Collateral in Lieu of Appearance in Accordance with Fed. R. Crim. P. 58(d)(1)

(a) A person who is charged with a violation of a federal wildlife act, parking regulations governing federal buildings, national forest offenses, conduct on Postal Service property, motor vehicle violations on Postal Service property, violations of law on military property, or any other petty offense as defined in 18 U.S.C. § 19, may, in lieu of appearance, post collateral in the amount indicated for the offense, waive appearance before a Magistrate Judge, and consent to the forfeiture of collateral. The offenses for which collateral may be posted and forfeited are set forth in an administrative order from the Court which may be obtained from the Clerk's Office. Those offenses marked with an asterisk and for which no amount of collateral is shown require a mandatory appearance before a Magistrate Judge.

(b) If a person charged with an offense under (a) fails to post and forfeit collateral, any punishment, including fine, imprisonment or probation, may be imposed within the limits established by law upon conviction or after trial.

(c) If, within the discretion of the law enforcement officer the offense is of an aggravated nature, the law enforcement officer may require appearance, and any punishment, including fine, imprisonment or probation, may be imposed within the limits established by law upon conviction or after trial.

(d) Nothing in this LCrR shall prohibit a law enforcement officer from arresting a person for the commission of any offense, including those for which collateral may be posted and forfeited, and requiring the person charged to appear before a Magistrate Judge or, upon arrest, taking the person immediately before a Magistrate Judge.

SCHEDULE OF FINES FOR OFFENSES COMMITTED
WITHIN A NATIONAL FOREST

Subpart A – General Prohibitions

36 CFR 261.3 INTERFERING WITH A FOREST OFFICER

The following are prohibited:

- (a) Threatening, resisting, intimidating, or interfering with any Forest Officer engaged in or on account of the performance of his/her official duties in the protection, improvement, or administration of the National Forest System is prohibited. **MA***
- (b) Giving any false, fictitious or fraudulent report or other information to any Forest Officer engaged in or on account of the performance of his official duties knowing that such report or other information contains false, fictitious or fraudulent statement or entry. **\$150**
- (c) Threatening, intimidating, or intentionally interfering with any Forest Officer, volunteer, or human resource program enrollee while engaged in, or on the account of, the performance of duties for the protection, improvement, or administration of the National Forest System or other duties assigned by the Forest Service. **MA***

36 CFR 261.4 DISORDERLY CONDUCT

The following are prohibited:

- (a) Engaging in fighting. **\$250**
- (b) Addressing any offensive, derisive, or annoying communication to any other person who is lawfully present when such communication has a direct tendency to cause acts of violence by the person to whom, individually, the remark is addressed. **\$150**
- (c) Make statements or other actions directed toward inciting or producing imminent lawless action and likely to incite or produce such action. **\$150**
- (d) Causing public inconvenience, annoyance, or alarm by making unreasonably loud noise. **\$150**

36 CFR 261.5 FIRE

The following are prohibited:

- (a) Carelessly or negligently throwing or placing any ignited substance or other substance that may cause a fire. **\$250**

(h) When commercially distributing printed material, delaying, halting, or preventing administrative use of an area by the Forest Service or other scheduled or existing uses or activities on National Forest System lands; misrepresenting the purposes or affiliations of those selling or distributing the material; or misrepresenting the availability of the material without cost. \$150

(i) Operating or using in or near a campsite, developed recreation site, or over an adjacent body of water without a permit, any device which produces noise, such as a radio, television, musical instrument, motor or engine in such a manner and at such a time so as to unreasonably disturb any person. \$100

(j) Operating or using a public address system, whether fixed, portable or vehicle mounted, in or near a campsite or developed recreation site or over an adjacent body of water without a special-use authorization. \$100

(k) Use or occupancy of National Forest System land or facilities without special-use authorization when such authorization is required. \$200

(l) Violating any term or condition of a special-use authorization, contract or approved operating plan. \$250

(m) Failing to stop a vehicle when directed to do so by a Forest Officer. \$250

(n) Failing to pay any special use fee or other charges as require. \$250

(o) Discharging or igniting a firecracker, rocket or other firework, or explosive into or within any cave. \$250

36 CFR 261.11 SANITATION

The following are prohibited:

(a) Depositing in any toilet, toilet vault, or plumbing fixture any substance which could damage or interfere with the operation or maintenance of the fixture. \$200

(b) Possessing or leaving refuse, debris, or litter in an exposed or unsanitary condition. \$200

(c) Placing in or near a stream, lake, or other water any substance which does or may pollute a stream, lake, or other water. \$250

(d) Failing to dispose of all garbage, including any paper, can, bottle, sewage, waste water or material, or rubbish either by removal from the site or area, or by depositing it into receptacles or at places provided for such purposes. \$200

(e) Dumping of any refuse, debris, trash or litter brought as such from private property or from land occupied under permit, except, where a container, dump or similar facility has been provided and is identified as such, to receive trash generated from private lands or lands occupied under permit. \$250

36 CFR 261.12 NATIONAL FOREST SYSTEM ROADS AND TRAILS

The following are prohibited:

- (a) Violating the load, weight, height, length, or width limitations prescribed by State law, except by special-use authorization of written agreement or by order issued under 261.54 of this Chapter. **\$150**
- (b) Failing to have a vehicle weighed at a Forest Service weighing station, if required by a sign. **\$100**
- (c) Damaging and leaving in a damaged condition any such road, trail, or segment thereof. **\$250**
- (d) Blocking, restricting, or otherwise interfering with the use of a road, trail, or gate. **\$150**

36 CFR 261.13 MOTOR VEHICLE USE

After National Forest System roads, National Forest System trails, and area on National Forest System lands have been designated pursuant to 36 CFR 212.51 on an administrative unit or a Ranger District of the National Forest System, and these designations have been identified on a motor vehicle use map, it is prohibited to possess or operate a motor vehicle on National Forest System lands in that administrative unit or Ranger District other than in accordance with those designations, provided that the following vehicles and uses are exempted from this prohibition: **\$150**

- (a) Aircraft;
- (b) Watercraft;
- (c) Over-snow vehicles;
- (d) Limited administrative use by Forest Service;
- (e) Use of any fire, military, emergency, or law enforcement vehicle for emergency purposes;
- (f) Authorized use of any combat or combat support vehicle for national defense purposes;
- (g) Law enforcement response to violations of law, including pursuit;
- (h) Motor vehicle use that is specifically authorized under a written authorization issued under Federal law or regulations; and
- (i) Use of a road or trail that is authorized by a legally documented right-of-way held by State, county, or other local public road authority.

36 CFR 261.14 USE BY OVER-SNOW VEHICLES

It is prohibited to possess or operate an over-snow vehicle on National Forest System lands in violation of a restriction or prohibition established pursuant to 36 CFR 212, subpart C, provided that the following uses are exempted from this section: **\$150**

(a) Limited administrative use by Forest Service;

(b) Use of any fire, military, emergency, or law enforcement vehicle for emergency purposes;

(c) Authorized use of any combat or combat support vehicle for national defense purposes;

(d) Law enforcement response to violations of law, including pursuit;

(e) Use by over-snow vehicles that is specifically authorized under a written authorization issued under Federal law or regulations; and

(f) Use of a road or trail that is authorized by a legally documented right-of-way held by a State, county, or other local public road authority.

36 CFR 261.15 USE OF VEHICLES OFF ROADS

It is prohibited to operate any vehicle off National Forest System, State or County roads:

(a) Without a valid license as required by State law. **\$150**

(b) Without an operable braking system. **\$150**

(c) From one-half hour after sunset to one-half hour before sunrise unless equipped with working head and tail lights. **\$100**

(d) In violation of any applicable noise emission standard established by any Federal or State agency. **\$100**

(e) While under the influence of alcohol or other drug; If alcohol is involved: with a blood alcohol level of .08 or greater, use mandatory appearance. Blood alcohol level of .02 to .08 use fine amount. For persons under 21 years of age, contact AUSA. **MA**

(f) Creating excessive or unusual smoke; **\$100**

(g) Carelessly, recklessly, or without regard for the safety of any person, or in a manner that endangers, or is likely to endanger, any person or property. **\$250**

(h) In a manner which damages or unreasonably disturbs the land, wildlife, or vegetative resources. **\$250**

(l) In violation of State law established for vehicles used off roads. \$150

36 CFR 261.16 DEVELOPED RECREATION SITES

The following are prohibited:

(a) Occupying any portion of the site for other than recreation purposes. \$50

(b) Building, attending, maintaining, or using a fire outside of a fire ring provided by the Forest Service for such purpose or outside of a stove, grill or fireplace. \$150

(c) Cleaning or washing any personal property, fish, animal, or food, or bathing or washing at a hydrant or water faucet not provided for that purpose. \$50

(d) Discharging or igniting a firecracker, rocket or other firework, or explosive. \$150

(e) Occupying between 10 p.m. and 6 a.m. a place designated for day use only. \$50

(f) Failing to remove all camping equipment or personal property when vacating the area or site. \$50

(g) Placing, maintaining, or using camping equipment except in a place specifically designated or provided for such equipment. \$75

(h) Without permission, failing to have at least one person occupy a camping area during the first night after camping equipment has been set up. \$75

(i) Leaving camping equipment unattended for more than 24 hours without permission. \$75

(j) Bringing in or possessing an animal, other than a seeing eye dog, unless it is crated, caged, or upon a leash not longer than six feet, or otherwise under physical restrictive control. \$50

(k) Bringing in or possessing in a swimming area an animal, other than a seeing eye dog. \$50

(l) Bringing in or possessing a saddle, pack, or draft animal except as authorized by posted instructions. \$50

(m) Operating or parking a motor vehicle or trailer except in places developed or designated for this purpose. \$50

(n) Operating a bicycle, motorbike, or motorcycle on a trail unless designated for this use. \$75

(o) Operating a motorbike, motorcycle, or other motor vehicle for any purpose other than entering or leaving the site. \$75

(p) Depositing any body waste except into receptacles provided for this purpose. \$100

Failure to pay any recreation fee is prohibited. Notwithstanding 18 U.S.C. 3571(e), the fine imposed for the first offense of nonpayment shall not exceed \$100. \$50

36 CFR 261.18 NATIONAL FOREST WILDERNESS

The following are prohibited in a National Forest Wilderness:

(a) Possessing or using a motor vehicle, motorboat or motorized equipment except as authorized by Federal law or regulation. \$200

(b) Possessing or using a hang glider or bicycle. \$200

(c) Landing of aircraft, or dropping or picking up of any material, supplies, or person by means or aircraft including a helicopter. \$200

36 CFR 261.22 UNAUTHORIZED USE OF "SMOKEY BEAR" AND "WOODSY OWL" SYMBOL

(a) Manufacture, importation, reproduction or use of "Smokey Bear" except as provided under 36 CFR 271.2, 271.3, or 271.4 is prohibited. MA*

(b) Manufacture, importation, reproduction or use of "Woodsy Owl" except as provided under 36 CFR 272.2, 272.3, 272.4 is prohibited. MA*
