ADMINISTRATIVE ORDER

Due to the death of Senior Judge Arthur J. Tarnow on January 21, 2022 his pending caseload will be reassigned as follows:

IT IS ORDERED that effective immediately, the Clerk will randomly reassign all pending civil and active miscellaneous cases currently assigned to Judge Tarnow, except as listed below.

IT IS FURTHER ORDERED that effective immediately, the Clerk will randomly reassign all pending criminal cases currently assigned to Judge Tarnow, except as listed below.

IT IS FURTHER ORDERED that the Clerk will randomly reassign fugitive criminal cases when the defendant makes their initial appearance or administrative action needs to be taken regarding the case.

IT IS FURTHER ORDERED that effective immediately, the Clerk will reassign all civil and criminal cases with post-judgment matters (including any §2255 motions) to Judge Terrence G. Berg in accordance with LR 83.11(b) and LCrR 57.10(b).

IT IS FURHTER ORDERED that effectively immediately, the Clerk will reassign all future civil and criminal cases where a post-judgment matter is filed (including any §2255 motions) in accordance with LR 83.11(b) and LCrR 57.10(b).

IT IS FURTHER ORDERED that the magistrate judges already assigned to those cases will not be changed because of the reassignment.
