
These rates are consistent with, and do not exceed, the maximum transcript fee rates approved by the Judicial Conference of the United States at its March 2018 session.

**MAXIMUM TRANSCRIPT FEE RATES - ALL PARTIES PER PAGE**  
**(Effective April 2, 2018)**

	<b>Original</b>	<b>First Copy to Each Party</b>	<b>Each Add'l Copy to the Same Party</b>
<b>Ordinary Transcript (30 day)</b> A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$3.65	\$0.90	\$0.60
<b>14-Day Transcript</b> A transcript to be delivered within fourteen (14) calendar days after receipt of an order.	\$4.25	\$0.90	\$0.60
<b>Expedited Transcript (7 day)</b> A transcript to be delivered within seven (7) calendar days after receipt of an order.	\$4.85	\$0.90	\$0.60
<b>3-Day Transcript</b> A transcript to be delivered within three (3) calendar days after receipt of an order.	\$5.45	\$1.05	\$0.75
<b>Daily Transcript</b> A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday), prior to the normal opening hour of the clerk's office.	\$6.05	\$1.20	\$0.90
<b>Hourly Transcript</b> A transcript of proceedings to be delivered within two (2) hours from receipt of the order.	\$7.25	\$1.20	\$0.90
<b>Realtime Transcript</b> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.	One feed <sup>1</sup> , \$3.05 per page; two-to-four feeds, \$2.10 per page; five or more feeds, \$1.50 per page.		

<sup>1</sup>A realtime "feed" is the electronic data flow from the court reporter to the computer of each person or party ordering and receiving the realtime transcription in the courtroom.
