STIPULATION TO RELEASE DEFENDANT ON HOME CONFINEMENT

The parties stipulate that Mr. Douglas is currently serving the remainder of his sentence of imprisonment of 15 months in this case. Mr. Douglas is scheduled to be released from prison June 26, 2020. He is currently being housed at FCI Milan and is eligible for halfway house placement. The parties further stipulate that despite his eligibility, the Bureau of Prisons will not release Mr. Douglas to a halfway house. The parties stipulate and jointly move for the Court to find that such circumstances present “extraordinary and compelling reasons” under 18 U.S.C. §3582(c)(1) to reduce Mr. Douglas’s sentence to a sentence of time served, followed by a 3-year term of supervised release. The parties agree to waive any requirement that Mr. Douglas exhaust administrative remedies such as petitioning his warden and waiting 30 days for a response. It is also stipulated that Mr. Douglas should be released on home confinement until June 26, 2020 – his maximum term of incarceration in this

case. The parties further stipulate that Mr. Douglas's release to home confinement is consistent with the First Step Act's recommendation for expanded use of home confinement and re-entry programming.

ORDER RELEASING DEFENDANT ON HOME CONFINEMENT

The Court has considered the parties' stipulation and joint motion to release defendant on home confinement. For the reasons described in the parties' submission, and after considering all of the factors outlined in 18 U.S.C. §3582(c), the Court finds that extraordinary and compelling reasons exist to reduce the defendant's sentence to a sentence of time served followed by a 3-year term of supervised release. The defendant's immediate release to home confinement is consistent with the First Step Act's recommendation for expanded use of home confinement and re-entry programming.

IT IS HEREBY ORDERED that the defendant's term of imprisonment be reduced to time served.

IT IS FURTHER ORDERED that as a condition of supervised release, that the defendant participate in home confinement until June 26, 2020.

IT IS SO ORDERED.
