October 1, 2024, respectively.

These rates are consistent with, and do not exceed, the maximum transcript fee

rates approved by the Judicial Conference of the United States at its September 2022

session.

In multi-defendant cases for defendants represented under the Criminal Justice

Act (CJA), the copy rate for subsequent CJA transcript orders is 19 cents per page. This

rate is the average commercially competitive rate based on recent price quotations for

duplication services within the Eastern District of Michigan.

This administrative order supersedes Administrative Order 18-AO-014 and Section

9(j) of Administrative Order 13-AO-029.
