#### ADMINISTRATIVE ORDER

It appearing that the current master jury wheels will expire on August 18, 2025, the Clerk of Court obtained lists of registered voters, licensed drivers, and state identification card holders for the counties that comprise the Eastern District of Michigan. The lists are used to create a master jury wheel for each of the Court's five jury divisions: Ann Arbor, Bay City, Detroit, Flint and Port Huron.

Pursuant to Sections (e) and (h) of the court's Juror Selection Plan, the Clerk has determined the minimum number of names to be selected at random to create a new master jury wheel for each division as follows.

Ann Arbor Division	100,000
Bay City Division	100,000
Detroit Division	500,000
Flint Division	100,000
Port Huron Division	10,000

For the purpose of determining proportional representation in each master jury wheel, the number of registered voters in each county of each division will be used. Once the proportional representation has been computed, the number of names to be randomly selected from each county of each division will be calculated.
