I, as the duly authorized representative of Volkswagen AG, defendant in this case, hereby acknowledge that I have received a copy of the **Third Superseding**Information before entering my plea, and that I have read it and understand its contents.

I know that if Volkswagen AG is convicted or pleads guilty, the corporation may be sentenced as follows:

Conspiracy – 18 U.S.C. § 371

A fine of up to \$500,000 or the greater of twice the gross gain or twice the gross loss; probation of up to 5 years;

Obstruction of Justice – 18 U.S.C. § 1512(c)

A fine of up to \$500,000 or the greater of twice the gross gain or twice the gross loss; probation of up to 5 years;

Entry of Goods by False Statement – 18 U.S.C. § 542

A fine of up to \$500,000 or the greater of twice the gross gain or twice the gross loss; probation of up to 5 years.
